Centrally located, Grand Junction is the largest city between Denver and Salt Lake City with direct access to I-70 and the Grand Junction Regional Airport (GJT). The Grand Junction area is home to one of the fastest growing universities in the nation, Colorado Mesa University, health care, and a diverse economic base featuring industry pioneers and cutting-edge tech and cyber security companies.

OPPORTUNITY ZONES

The Grand Junction area is home to seven federally designated Opportunity Zones. Private investment can enjoy tax incentives for investing in real estate projects and operating businesses in the area. Investors can receive tax incentives through deferrals, reductions, and possible elimination of certain federal capital gains taxes.



RURAL JUMP-START TAX CREDIT PROGRAM

Accelerate growth and innovation with the Rural Jump Start Program.

Participating companies may be eligible to receive significant tax breaks and cash grants for up to 8 years including up to \$20,000 as a newly established business in the region and up to \$2,500 per new hire.
